By law pharmaceutical companies are required to conduct pharmacovigilance activities on all drugs on the market and those in clinical trials. Due to the ever increasing regulatory requirements, the increasing number of clinical trials on new drugs and the increasing number of drugs introduced to the market, the need for skilled staff in the field of pharmacovigilance continues to grow.

Pharmacovigilance is part of the discipline of Pharmaceutical Medicine which in turn is a recognised specialty/faculty of the Royal College of Physicians.
